role in the differentiation of GCTs. We studied the pattern of expression of PKC isoforms in GCTs of low malignant potential (LMP) (n = 18), borderline malignancy (BML, n = 18), and malignant potential (MLP, n = 18) and compared this pattern to that of theca cell tumors (TCTs) and follicles of the human ovary. Western blot and immunohistochemistry analysis were done on paraffin-embedded tissue and on frozen sections of

paraffin blocks using isoformspecific antipeptide antibodies and isoform-specific activity inhibitors. PKC activity was determined using an in vitro phosphorylation assay. PKC betaI and PKC betaII were differentially expressed in the groups. The PKC isoforms were more homogeneously expressed in MLP and LMP GCTs than in the BML and MLP GCTs. There was more staining for PKC betaI in the theca cells than in the

follicles. PKC alpha and PKC epsilon were present in theca cells. No significant difference in PKC activity was demonstrated between GCT subgroups. PKC isoforms are differentially expressed in GCTs at different stages of differentiation. PKC activity seems to be regulated in GCTs, but the involvement of PKC isoforms in the regulation of human GCTs does not appear to be as important as in other cell types. In GCTs, a new role for

PKC betaI seems to be the regulation of steroid production. This study also points out the fundamental differences between steroidogenic and nonsteroidogenic cell types in that the calcium-dependent activation of PKC is necessary for steroid production in the former.
